Proposed Changes to the UCR Agreement Are on the Way

The Unified Carrier Registration Agreement is the interstate agreement between the UCR Plan Board of Directors and the 41 states participating in the UCR Plan. The UCR Agreement governs the collection and distribution of registration and financial responsibility information and fees paid by covered motor carriers and others under the UCR Act. The UCR Plan Board of Directors and staff have been reviewing the UCR Agreement and have determined that the Agreement needs updating. At the UCR Plan Board of Directors meeting on June 6, 2024, the Board adopted a procedure for considering amendments to the UCR Agreement. A copy of that procedure has been posted to the Policies and Procedures page of the UCR website. The procedure provides for publication of any proposed amendments to the UCR Agreement to allow for a period of public comment.
