State Carrier Audit Reports Due June 1



States participating in the UCR program are required to conduct an annual audit of their carriers. These audits should have been completed by March 31, 2022. Final audit reports are viewed by the Audit Subcommittee in the admin portal of the National Registration System (NRS) on **June 1, 2022**.

Policy Spotlight: UCR Mandatory Training Policy



UCR requires at least one representative from each participating state to watch each new virtual training within 30 days of its release. UCR also requires at least one state representative to attend each in-person training session when scheduled. UCR will reimburse one attendee from each state for travel expenses under the federal travel regulation rates and requirements incurred for attending any mandatory in-person UCR trainings.
