## UCR Policy Spotlight: Suspended Payment Method(s)

In situations of misuse or abuse of a certain payment method by motor carriers or registration permitting services, it may be necessary to suspend the registrant from paying by that particular payment method. This policy is intended to define situations when



misuse or abuse of a payment method occurs and the restrictions to that payment method that will result. This policy is not designed to prevent an entity from registering with the UCR Plan, but rather to restrict a payment method when misuse or abuse is observed.
