Start of 2020 UCR Registration Period Remains Delayed

Board to Review Enforcement Delay at Jan. 28 Meeting

The start of the 2020 UCR registration period for the 2020 remains delayed until further notice. The Federal Motor Carrier Safety Administration (FMCSA) has confirmed that the process to establish a final rulemaking for 2020 is still underway within the agency.

The UCR Board of Directors recommends that states and law enforcement delay enforcement for three months starting from the effective date of the 2020 fees.

The Board will review the current situation at its next meeting on January 28. UCR will provide more information once fees for the 2020 registration year are effective. Check the [UCR website](#) for updates.

States participating in the UCR program are required to conduct an annual audit of their carriers. Final audit reports must be submitted **through the admin portal of the National Registration System** by June 1, 2020.
