# UCR Updates Definition of a Commercial Motor Vehicle

The UCR Act requires transportation operations to register and pay annual fees for commercial motor vehicles involved in interstate or international commerce. The UCR Board has updated the definition of a commercial motor vehicle for clarity by adding the text in bold below.

For purposes of the UCR, a commercial motor vehicle is defined as: *A self-propelled vehicle used on the highways in commerce principally to transport passengers or cargo, if the vehicle:* 

- Has a gross vehicle weight rating or gross vehicle weight of at least 10,001 pounds, whichever is greater, or when connected to trailing equipment has a gross combination weight rating or gross combination weight of at least 10,001 pounds, whichever is greater, or
- Carries placarded amounts of hazardous materials, regardless of the vehicle's weight, or
- Is designed to carry more than 10 passengers, including the driver.

The above is consistent with the definition of a commercial motor vehicle as set forth by reference in the UCR Act (49 U.S. Code § 31101.)

# UCR Policy Spotlight: Refund Procedure

UCR refunds can be given if the fee was paid in error, if the registration is corrected to a lower fee bracket, or if a registrant
