Annual Carrier Audit Deadline Extended to July 1

States participating in the UCR program are required to conduct an annual audit of their carriers in accordance with Section 19 of the UCR Agreement. The UCR Board has decided to extend the deadline for these audits to July 1, 2020, due to the unprecedented circumstances of the COVID-19 outbreak. This means states now have until July 1 to complete their assigned carrier audits for the 2019 registration year in the [admin portal](#) of the National Registration System. After the July 1 deadline, states must continue to perform carrier audits for the 2019 registration year that are assigned in the NRS and [FARs website](#).
